## SPECIAL MEETING OF THE KIMBERLY VILLAGE BOARD MINUTES August 8, 2022

President Kuen called the meeting to order at 6:00. Appearing in person were Trustees Gaffney, Hietpas, Hammen and Weber. Also present were Interim Administrator Hermus, Clerk-Treasurer Weyenberg, Department of Operations Dannhoff, Community Enrichment Director Femal. Community Enrichment Director Femal reported that their department received free dirt from Don Hietpas and Sons. They will be using that to prepare the ice rink for this winter. Touch A Truck was another success this year. Beach staff, along with P&R Summer Assistant Hallie Dix will be touching up some of the unique and unwanted artwork located in the tunnel by the YMCA.

Library Director Selwitschka was absent.

Community Development Interim Director Hermus reported that development on the trails is moving forward and is on schedule. Last 2 lots in Papermill Estates have been closed on and structures are being built. Paperwork for filing upcoming grants is being organized and nearing completion.

Interim Administrator Hermus reported that the Strategic Planning meetings are wrapping up (tonight after the board meeting) and with staff next week. A transition plan is also being put together for the new Administrator coming in.
