President's POINT OF VIEW

2026 - What's Ahead in the Village

We are now fully embraced in the year 2026, having experienced significant cold temperatures and witnessing disturbing activities around the country. Regardless of which “side of aisle” you may find yourselves, the divisiveness experienced throughout January is unsettling, I remain hopeful that differences can be abated and we can be a harmonious society going forward. Within the Village of Kimberly we have opportunities to engage in positive and productive activities as 2026 progresses.

Your parks and recreation leadership have many opportunities for young and old. From babysitting classes, youth baseball, adult field trips, the Bunny Hop, Pumpkin Walk and Christmas at the Pond events, you can find community centered activities to engage in. The library team has a plethora of programs planned for young and “seasoned” patrons. Your amazing volunteer firefighters/EMS team will host a couple of fundraisers, the KRA will offer opportunities for recreation and socializing and the Paperfest will return for summertime community celebration—So much to do within the village.

2026 will bring orange barrels as we continue to maintain streets and sewers with a complete rebuild of Schindler Drive as a part of our long range plan. The central office in the Municipal Complex will be receiving a much needed refresh with enhanced security and upgrades to technology. The street and parks crews will be keeping the community clean and maintained. Winter remnants of potholes will be fixed, deteriorating concrete panels replaced, streets swept and parks beautified. The scenic overlook along Papermill Run will open and trails will be maintained.

In 2026 we continue planning for the future, while seeking grants and working cooperatively at a regional level. These efforts should yield support for grant funding to reconstruct Kennedy Ave. from Railroad St. to Kimberly Ave. We anticipate a positive vote to award funding of 80% of the multi-million dollar project through the Metropolitan Planning Organization (MPO) aligned with the East Central Wisconsin Regional Planning Commission. I serve on the Policy Committee with this regional organization and Administrator Block serves on the Technical Advisory Committee of the organization. The work of the MPO includes rating the many projects for street improvements throughout communities from Oshkosh through Kaukauna and strategically designating available federal funding to projects throughout the region. Through sound planning and narratives centered on the need and value of improving Kennedy Ave., it ranked highest in need and improved regional value which would generate the funding to complete the work in 2030. While we certainly wish it could be sooner, this grant will allow for the much needed reconstruct along with signalization of the Eisenhower/Kennedy intersection and designated bike lanes to enhance safety in this well utilized corridor.

As this edition reaches you, the retirement of Judge Jerry Schuman will have happened. We appreciate Jerry's long term commitment to serving in the Municipal Judge role. Presiding fairly and consistently, Jerry's work has impacted many. From redirecting a youngster who may have experienced a youthful bad decision to ceremoniously uniting couples in matrimony, Jerry has been a positive representative of the community. Thank you Jerry!



FRIENDLY WINTER REMINDERS AS WE AWAIT SPRING'S ARRIVAL:

Residents are reminded to check where their sump pumps are discharging. Water may not be discharged onto the public right-of-way, sidewalks, or roadways, as this can create slippery and hazardous conditions. This is prohibited under Village Ordinance 207.27.

Once the spring melt is underway, please also take care to ensure sump pump discharge is not directed toward neighboring properties, as excess runoff can cause issues for others.

To help manage drainage, the Village allows homeowners to connect their sump pump to a mini sewer where available. This option helps move water away efficiently and prevents it from continually recycling through the ground around your home. Thank you for helping keep our sidewalks, streets and neighborhoods safe!



We know it's tempting.

Residents are reminded that pushing or plowing snow from private property across the roadway, or blowing snow from sidewalks or driveways into the street, is not permitted by Village ordinance 430.10. This practice can create very unsafe conditions, including slippery roads and reduced traction for vehicles.

NOTICE OF WATER RATE INCREASE

The Kimberly Water Utility filed an application with the Wisconsin Public Service Commission (PSC) for a water rate increase for the first time since 2019. The PSC issued a final decision to the Water Utility on December 15, 2025. The Kimberly Water Utility acknowledged and received the rates on January 13, 2026, with an effective date of February 1, 2026. The new rates are shown in the tables below.

The increase is necessary to properly maintain the water utility's operations, infrastructure, and equipment. Since the last adjustment the cost of operating the water utility has remained relatively flat, while material and treatment costs have increased significantly.

The Kimberly Water Utility is committed to efficient delivery of water. Kimberly water rates will remain among the lowest across neighboring communities.

Included with the rate case, the Village of Kimberly Water Utility elected to convert all Public Fire Protection Charge from the tax bill/levy charge to the water bill/utility charge. Below are frequently asked questions regarding the Water Utility and Public Fire Protection Charges:

1. What is the purpose of a Water Utility?

A water utility has several basic functions: 1) furnishing water for consumption; 2) furnishing water for sanitation; and 3) capability to deliver water for fighting fires.

2. What is the Public Fire Protection Charge?

This charge is required by State law and regulated by the State of Wisconsin's Public Service Commission. It recovers the cost of water for fighting fires and the extra capacity built into the system to rapidly deliver a large volume of water to fight a fire anywhere within the Water Utility's service area. These costs include a portion of wells, pumps, storage facilities, water mains, hydrants and an estimated quantity of water used for this purpose.

3. How has Public Fire Protection been paid for in the past?

Prior to 2026, the Village had been using the property tax levy to subsidize these costs for the utility customers to maintain a lower cost of water service for residents and businesses currently connected to the system. The service was paid in part both through property tax levy and a fee on the utility bill.

4. Why have Village taxpayers been paying for a Water Utility expense?

Prior to 2026, the Village had been using the property tax levy to subsidize these costs for the utility customers to maintain a lower cost of water service for residents and businesses currently connected to the system.

5. Why is this fee on my Utility Bill?

Due to budget constraints, state-imposed property tax levy limits, and lagging state aids, the Village can no longer subsidize the water utility with general property taxes. Utility customers now pay for a service that was previously subsidized by only Kimberly property taxpayers. All utility customers are treated equally and non-profits, tax-exempt entities also pay for their share of the Public Fire Protection costs. Which is a service that they receive. It is a more equitable allocation of costs. By moving the charge to the utility bills, the Village now has approximately \$100,000 available for other operating or capital expenditures such as the maintenance and/or replacement of Village equipment, buildings and services.

6. Isn't this a cost that should be borne by the Fire Department and not the Utility customers? Isn't this why I pay taxes?

This charge has nothing to do with the costs of operating the Kimberly Fire Department. The Public Fire Protection Charge covers the costs of the Kimberly Water Utility to be able to deliver water for fighting fires and is completely independent of any expenses that the Kimberly Fire Department may incur in order to use the water to fight the fire.

7. This is just a utility rate increase, isn't it?

No, the utility is not receiving any increase in revenue this is just the same amount of money coming from a different source – a direct charge on your utility bill rather than from the Village's general property tax collections.

8. What costs does the Public Fire Protection Charge specifically cover?

Although hydrants are an important part of the cost, there are other expenses, such as increased size of water mains, increased pump capacity, and increased storage capacity (water towers) that all must be in place to supply water to fight a fire. These things must be in place to make sure the water utility has enough capacity to provide water for fighting fires and still supply daily water needs at the same time. If the water system was not utilized to fight fires, the system would cost the utility significantly less to operate and maintain due to smaller mains, pumps and storage facilities.

9. I have multiple water meters; will I receive a charge for every meter?

Any meter providing general service (being consumed, used in a manufacturing process, discharge to the sanitary sewer, etc.) receives the Public Fire Protection Charge according to the size of their primary meter. (Continued on Page 4)

10. Do other municipalities have a Public Fire Protection Charge?

There are 584 water utilities in Wisconsin regulated by the Wisconsin Public Service Commission (PSC). According to the PSC, nearly half (46%) of the Wisconsin water utilities recover all of the Public Fire Protection costs from direct charges placed on water utility bills. And only 33% of the utilities rely solely on municipal charges through property tax levy. And the remaining utilities have a combination of direct charges on the utility bills and property tax levy. Due to state imposed levy limits, more municipalities are shifting to directly billing utility customers for Public Fire Protection costs.

11. How is the amount of the Public Fire Protection charge determined?

The PSC has approved using the equivalent meters method to calculate the amount of Public Fire Protection charge. Under this method, the rate paid by each customer is based on the size of their water meter and service. Customers such as businesses, industries, and schools with larger water services will pay a proportionally larger charge for Public Fire Protection.

12. Does the Public Fire Protection Charge apply to Tax Exempt Properties?

Yes, all utility customers are responsible for paying the Public Fire Protection Charge, including churches, schools and government entities. Each utility customer pays the same rate as any other customer with the same meter size.

13. What will my new charge be for Public Fire Protection?

The PSC has determined that the following rates will apply:

Kimberly Water Department Customers 2026 Semi Annual Hydrant Flushing

The Kimberly Water Department will be cleaning and flushing water mains from 7:00 a.m. to 3:00 p.m. beginning April 20th – 23rd and April 27th – April 30th. The flushing will remove most of the natural minerals that have settled in the mains such as iron, a harmless-reddish brown mineral that does discolor the water.

If you observe Water Utility Personnel working in your area, refrain from using water or use as little as possible for 45 minutes to ensure that the water has settled in the mains. This will also help prevent any iron from being drawn into your water piping system.

If you do find that your water has become discolored, refrain from using it for an additional 30 minutes. Then draw off the remaining discolored water through the COLD WATER FAUCET ONLY.

Your cooperation during this flushing procedure will benefit all water customers.

DOG LICENSES



In accordance with State Statutes and Village Ordinance, dogs must be licensed annually, and must be done so within 30 days of residency in the Village. 2026 dog licenses are now available at the Municipal Complex. When applying for a dog license, owners must present the current rabies vaccination certificate. Every dog 5 months or older must have a current rabies shot. Neutered and spayed licenses are \$7.00, intact dog licenses are \$12.00. Failure to license your dog may result in a \$124.00 citation per dog. Late fee applied after March 31st. Licenses may be obtained:

- In person at the Kimberly Municipal Complex during office hours.
- By mailing in or by using the payment drop box: sending a copy of your dog's rabies certificate, with payment and a self addressed and stamped envelope. The license tag will be mailed to you.

REGISTER

PROOF OF RESIDENCY

Registering online is easy, safe and secure. You can register online or by mail up to 20 days before an election. If you have a valid WI Driver License or WI ID card issued by the DMV you can register online at myvote.wi.gov. If you prefer to register in-person, you can register in our office up until the Friday before an election or at your polling place.

If you have a valid WI driver license, you must provide the number and expiration date. Please note you cannot register on the Saturday, Sunday, or Monday before an election.

You must always provide Proof of Residency when registering to vote. It must include your name and current residential address. Acceptable forms include:

- A current and valid State of WI or State ID Card
- Any other official identification card or license issued by a WI governmental body or unit
- Any identification card issued by an employer in the normal course of business and bearing a photo of the card holder (not including a business card)
- A real estate tax bill or receipt for the current year or the year preceding the date of the election
- Residential lease that is effective on date of registration (NOT valid if registering by mail)
- A gas, electric, or telephone service statement (aka utility bill) for the period commencing no earlier than 90 days before the date of registration
- A university, college, or technical college identification card (must include photo) ONLY if the voter provides a fee receipt dated within the last 9 months or the institution provides a certified housing list to the municipal clerk
- An intake document from a residential care facility such as a nursing home or assisted living facility
- A bank, or credit union statement, regardless of the type of account or any credit card statement





POLICE DEPARTMENT

Beginning in 2026, to ensure adequate coverage, the Village of Kimberly has contracted with Outagamie County Sheriff's Department for additional police services. The police services contract with Outagamie County is not about duplicating efforts or increasing costs – it's about maintaining the level of safety our community expects and deserves. The agreement stays fully within the Village of Kimberly's adopted police services budget and ensures we have the staffing necessary to respond effectively and keep our neighborhoods secure.

Starting January 1st, 2026, deputies will patrol the Village of Kimberly from 5am to 5pm. As the transition in policing continues, the Village will phase in an additional six patrol deputies (eight total), two sergeants/investigator and one lieutenant for dedicated service to Kimberly. As updates become available, and additional staff is brought on – information will be posted to our website.


